Institutional Participation Agreement and Instructions April 2016 NCC and NCC/CCMHC Application Cycle

Introduction

Thank you for your interest in participating in the April 2016 National Certified Counselor (NCC) and National Certified Counselor/Certified Clinical Mental Health Counselor (NCC/CCMHC) application cycle. Please submit a signed participation agreement and roster of students, both of which are required. Terms and conditions for university participation as well as instructions for preparing the list of students follow.

The NCC application process gives well-advanced counseling students a unique opportunity to begin the certification process. As part of the application for NCC certification, students can take either the National Counselor Examination for Licensure and Certification (NCE) or the National Clinical Mental Health Counseling Examination (NCMHCE). The application fee is \$335. Students who will not be testing on campus will also pay a \$25 site fee.

Students enrolled in clinical mental health counseling programs that require 60 semester hours/90 quarter hours are eligible to apply for the National Certified Counselor (NCC)/Certified Clinical Mental Health Counselor (CCMHC) combination application. As part of the NCC/CCMHC application process, students take the NCMHCE. Because students earn two national certifications with the NCC/CCMHC application, the application fee is \$425.

Conditions for Your Institution's Participation

Institutions must adhere to the following conditions:

- The university will instruct students about national certification and how it differs from state licensure.
- Student participation in the application process must be voluntary. The institution cannot use the NCE or the NCMHCE as a comprehensive examination or a graduation requirement.
- Each student must meet NBCC's educational requirements prior to graduation. Each participating track is either
 accredited by the Council for Accreditation of Counseling & Related Educational Programs (CACREP) or the
 curriculum has been preapproved by NBCC. Note: If changes in the preapproved coursework have occurred since
 the last application cycle, the university must inform NBCC. There is no guarantee that NBCC will accept the
 revised curriculum.
- NBCC must approve and register a minimum of three applicants for the exam by the close of the application cycle
 in order for the exam to be held on campus. If the minimum is not met, alternate testing sites are available in each
 of the 50 states. Applicants choosing the NCMHCE will test off-campus with arrangements made through our
 computer-based testing partner, Pearson Vue.
- The institution will designate a campus coordinator and exam administrator to assist NBCC in offering this
 opportunity. The exam administrator cannot be a faculty member, student or staff member in the
 counseling department.
- A student who has been dismissed from the program is not eligible to apply for the NCC or NCC/CCMHC under this option. Should a student applicant be dismissed from the program after submitting an application to NBCC, the university agrees to notify NBCC in writing.

Application Eligibility Requirements for Counseling Students

Students must meet the following requirements in order to apply for the NCC or NCC/CCMHC:

- Degree-seeking counseling students are eligible to apply for the NCC or the NCC/CCMHC. They must be currently enrolled in a counseling track in a master's, specialist or doctoral program. Students enrolled in certificate programs or taking additional courses for licensure are not eligible to apply.
- Prior to graduating, students must complete a minimum of 48 semester hours/72 quarter hours of graduate-level coursework in counseling for the NCC or 60 semester hours/90 quarter hours for the NCC/CCMHC. Note: Students' exam scores are inactivated if they fail to complete the requirements for the NCC or NCC/CCMHC certification within a specified time period.
- Prior to graduating, student applicants must fulfill coursework requirements for the NCC or NCC/CCMHC.
 NBCC must preapprove the courses that cover the eight required content areas.
- Before submitting an NCC or NCC/CCMHC application, students must be well-advanced in their program of study. At a minimum, they must have completed coursework in six of the eight required subject areas and be enrolled in the final two during the semester of the exam.

Instructions for Submitting the Student Roster

The roster can be submitted electronically in either Word format or as a spreadsheet. **No handwritten rosters will be accepted.** The roster must include the following information: full name (no nicknames) of all well-advanced students from approved counseling tracks at your institution, e-mail address, degree type, degree track, expected graduation date, and application type (NCC or NCC/CCMHC). NBCC will contact students directly with an application link and instructions.
